Absence Due to Military Service

Active or reserve U.S. military members who must withdraw from classes due to military orders may receive a “MW” grade, with verified documentation of military orders.

Once verified, an “MW” will be recorded unless academic credit has already been earned.

“MW” grades do not affect academic progress, probation, or dismissal status.

If you receive orders, please contact the Admissions and Records Office. Complete the [General Petition](#) along with a copy of your orders.

Joint Service Transcripts/ Credit For Prior Learning

All students using VA benefits must submit official transcripts from all previously attended schools, including the Joint Services Transcript (JST). The Veterans Freedom Center can request your JST for you—just complete the JST Request Authorization Form. This free service only applies to your JST. Air Force veterans must request transcripts directly from the Community College of the Air Force (CCAF) at www.airuniversity.af.edu/Barnes/CCAF, as JST does not include Air Force records.

Students interested in Credit for Prior Learning using Joint Service Transcripts shall receive credit as recommended by the American Council on Education (ACE) Directory and approved by the appropriate discipline faculty of the college. For more information, please contact cpl@evc.edu.

EVC's Policy on Transfer Credits -

External Transcript Evaluation Request

Students with [ACCRAO-accredited transfer credits](#) may apply them toward EVC graduation or General Education requirements..

In order to have external transcripts evaluated for credit, it is the students' responsibility to complete and do the following:

- Complete 12 EVC units, then submit a External Transcript Evaluation Request Form
- Official transcripts must be submitted before the request is completed

Please note that the courtesy unofficial evaluation done during the first counseling meeting does not count as the official transcript evaluation

Transcripts from Other Institutions

Official transcripts from all previously attended colleges MUST be submitted to the EVC Office of Admissions and Records.

- Unofficial transcripts may be used for initial counseling and educational planning.
- Official transcripts are required to clear a degree, certificate, or continue VA certification after the first semester.

Students will have a one-semester grace period to submit ALL official transcripts from other colleges.

Students who fail to submit official transcripts, or who refuse or withhold submission, **will not be certified** after the one-semester grace period

Academic Probation

A student who has attempted at least 12 semester units of college courses and has a cumulative grade point average of less than 2.0 will be placed on Academic Probation I. A student on Academic Probation I who does not raise their cumulative grade point average to 2.0 or higher in the following semester will be placed on Academic Probation II.

Veterans lose certification for Veterans Benefits after two semesters of academic probation.

A student on Academic Probation II who does not raise their cumulative grade point average to 2.0 or higher in the following semester of attendance will be dismissed. The first time a student is dismissed, he or she may apply for readmission.

III. Important VA Educational Benefits Policies

Amount of Cost Covered by VA Benefits

Prospective students can use the [GI Bill Comparison Tool](#) to estimate benefits, including housing and book stipends, by school.

For details on your specific benefit, contact the Veterans Freedom Center or visit VA.gov. Monthly stipends vary by benefit type, rate of pursuit, and region.

Prohibition of Automatic Enrollment Certification

Each semester students using VA Educational Benefits are required to meet with the Veterans Counselor to plan approved courses.

After registering, students are required to submit the [Class Certification Form \(CCF\)](#). CCFs can be emailed to evcvet@evc.edu or submitted in-person.

Courses will not be automatically certified without meeting with the Veterans counselor or submitting a CCF.

Requirements for In-State Tuition

Students using GI Bill benefits under Ch. 30, 31, or 33 are exempt from nonresident tuition, regardless of separation date

Student Representation Fee
